The evening ended with the opening of the "Photo Voice" exhibition, coordinated by PAG-ASA and featuring survivors of human trafficking.

Victims of sexual abuse face many obstacles when it comes to enforcing their rights, and rarely can express themselves. Nevertheless, their voice remains essential to improve existing protection systems and to better support victims.

A KEY ROUND TABLE

On 16 November 2018, during the European Day for the Protection of children against sexual exploitation and sexual abuse, ECPAT Belgium and the FPS Justice co-organized a round table, bringing together adult victims, the police and judges.

During this event, victims' voices were under significant spotlight. Therefore, they were able to share their experiences with representatives of the police and judiciary.

What obstacles did they have to overcome to report? How was their testimony received and by whom? Were they informed of the main steps of the investigation? Did they feel supported during the legal proceedings? How can the police and the judiciary improve their support, regardless of when the complaint was lodged?

The event's relevance was unanimously underlined by participants. The recommendations drafted by the victims will serve as a basis for concrete changes. This marks the beginning of a promising process towards better justice.



MOBILIZE

"It seems to me that our society does not want to see, hear or testify when it comes to serious crimes. When will we stop considering human trafficking networks as mere myths? Shame must change sides" (testimony of a survivor, Jeudi de l'Hémicycle)

For shame to change sides, it is vital to mobilize. Not only political decision-makers, but anyone who can help stopping child sexual abuse. To this end, ECPAT Belgium uses all means available, both at national and European levels: advocacy actions, strategic partnerships, analysis writing and social networks.

JEUDI DE L'HEMICYCLE "CHILD TRAFFICKING IN BELGIUM"

On 8 November 2018, ECPAT Belgium came to the Frenchspeaking Parliament of Brussels to raise awareness among about child parliamentarians trafficking in Belgium. In the morning, several professionals came to testify: police officers, the judiciary, employees of victims' shelters and the national rapporteur on trafficking. They reached the following conclusion: there is an urgent need for detection and protection improvement.

Parliamentarians are committed to implementing the concrete recommendations presented on that day. Let's keep an eye on this.

The fight against child exploitation must take place beyond national borders. ECPAT Belgium is therefore delighted to have taken part to a unique event, co-organized by ECPAT International in Bogota (Colombia). The summit gathered 400 participants (from governments, the tourism industry, the police, the judiciary, civil society) from 25 countries ready to implement concrete measures to eradicate the sexual exploitation of children in travel and tourism.

ECPAT Belgium took advantage of this Colombian event to participate to the International Assembly of the ECPAT network, bringing together all of the 104 member organizations. A significant day as it marked the vote of the movement's new strategy (2018-2021), as well as an opportunity to meet, share, exchange!
